

RULES & REGULATIONS
of the 11th PKO Night Wrocław Half Marathon
14th of June 2025

I. GOAL

1. Popularization and promotion of running as a form of physical activity.
2. Promotion of the city of Wrocław in Poland and abroad.

II. ORGANISER

1. The Half Marathon is organized by the Wrocław Municipality – The Youth Sports Centre in Wrocław, PL 51-612 Wrocław, al. I. J. Paderewskiego 35, telephone +48 519 073603 email: biuro.zawodow@mcs.wroc.pl, www.mcs.wroc.pl/polmaraton.
2. The contact with the Organiser is possible by phone, on business days (Monday to Friday 8:00 a.m. to 3:00 p.m.) or to the email address: biuro.zawodow@mcs.wroc.pl.
3. The 11th PKO Night Wrocław Half Marathon shall be held under the patronage of the Mayor of the City of Wrocław.

III. DATE and PLACE

1. The 11th PKO Night Wrocław Half Marathon (hereinafter referred to as the **Event** or the **Race**) shall take place on 14th of June 2025 (Saturday), in Wrocław.
2. **The start:** The Olympic Stadium, at 10:00 p.m. (al. I. J. Paderewskiego 35, 51-612 Wrocław). Competitors must appear at the start line between 9:30 p.m. and 9:40 p.m.
The finish: The Olympic Stadium (al. I. J. Paderewskiego 35, 51-612 Wrocław).

IV. ROUTE

1. The Half Marathon route runs along the streets of Wrocław. The distance: 21.0975 km. The course is AIMS, WA, PZL-certified.
2. Along the route each kilometre shall be marked: **from 1st to 21st (every 1 km)**.
3. Along the route there shall be located:
 - a. water stations (located at the **5th, 10th, 15th, 18th km**).
 - b. refreshment stations with isotonic drinks and nutritious products (placed at about **10th, 18th km**).
 - c. medical aid stations – along with water and refreshment stations
 - d. toilets – along with water and refreshment stations
 - e. water curtains – minimum two and/or maximum four
4. The Organiser shall not accept any private supplements at water and refreshment stations.
5. The time control checkpoints shall be placed at the **start line**, at the **5th, 10th, 15th, 20th km**, and at the **finish line**.

6. The route runs on asphalt surface, with exception of its cobbled sections. The exact share of the cobbled sections shall be published in the Race separate announcement.
7. The exact route of the Race shall be announced at www.mcs.wroc.pl/polmaraton. The Organiser reserves the right to change the announced route of the Race, which shall be published at the afore mentioned website. No such change shall result in the right to press any additional claims against the Organiser.
8. The route shall be closed off for longitudinal road traffic according to the applicable decision concerning special use of roads. The exact time for the route closure shall be announced at www.mcs.wroc.pl/polmaraton.

V. START ZONES

1. Competitors are allocated to designated, colour-marked start zones (based on their predicted finish time declared in their entry form). Relevant colours are marked in their race numbers.
2. Each zone is colour-marked:
 - a. RED – competitors with the predicted Race finish time below 1:30
 - b. GREEN – competitors with the predicted Race finish time between 1:31 - 1:40
 - c. ORANGE - competitors with the predicted Race finish time between 1:41 – 1:50
 - d. BLUE – competitors with the predicted Race finish time between 1:51 – 2:00
 - e. PURPLE – competitors with the predicted Race finish time between 2:01 – 2:10
 - f. YELLOW – competitors with the predicted Race finish time between 2:11 – 3:00
3. Competitors must appear at the start line between 9:30 p.m. and 9:40 p.m.
4. Competitors will start their race in waves, starting with the RED-zone competitors, then competitors according to their declared finish time, in time intervals.

VI. TIME LIMIT

1. Competitors are subject to a net time limit of 3 hours.
2. Competitors who reach the halfway point of the Race in time longer than 1.5 h shall discontinue their Race and go off the Race route.
3. All competitors who fail to complete the Race before 1:30 a.m. shall go off the Race route or reach the finish line on a bus with the sign 'END OF RACE.'
4. Competitors who decide to remain on the Race route after the specified time limit do so at their own risk and responsibility, in accordance with traffic regulations and the Civil Code provisions.

VII. TIME MEASUREMENT

1. Time measurement and ranking shall be carried out by the electronic system, based on chips integrated with starting numbers.
2. Each Competitor shall receive a race kit containing a race number with a timing chip,

and their proper attachment is the condition for starting in the Race and being included in the Race final classification.

3. The Race general classification shall be based on actual times (net time – counted from the moment of crossing the start line). The first 50 competitors shall be classified based on official times (gross time – counted from the starter's shot).
4. In the final Race results announcement, each Competitor receives information about both their gross and net times.

VIII. VERIFICATION AND COLLECTION OF RACE KITS

1. All Competitors of the 11th PKO Night Wrocław Half Marathon must undergo identity verification at the Race Office. The Race Office will be located in the Olympic Stadium (Al. I. J. Paderewskiego 35, 51-612 Wrocław), the exact localization shall be announced at the website: www.mcs.wroc.pl/polmaraton.
2. Working hours of the Race Office:
 - a. Thursday **12.06.2025 3:00 p.m. – 8:00 p.m.**
 - b. Friday **13.06.2025 12:00 – 8:00 p.m.**
 - c. Saturday **14.06.2025 10:00 a.m. – 9:00 p.m.**
3. Competitors may undergo their identity verification at the Race Office:
 - a. personally – based on the QR code (either printed-out or displayed on a mobile phone screen. The code may be downloaded from the Competitor's profile, an e-mail or an SMS message received from the Organiser)
 - b. by an authorised person – based on a QR code made available by the Competitor.
4. In the absence of a QR code, a Competitor needs to have an identity document (an ID card, passport) for the purpose of their identity verification, date of birth and nationality.
5. The Race Office shall verify Competitors identity, distribute race numbers, and race kits referred to in Chapter XI hereof.
6. The Race Office shall verify the fee payment and rights to discounts.
7. The Organiser shall not send race kits.
8. No race kits shall be distributed after the deadline. In extraordinary situations justified by actions of force majeure, a race kit may be collected after the afore specified deadline, at the Organiser's sole discretion.

IX. PARTICIPATION

1. Only individuals who will turn 18 years old by 14th of June 2025 may participate in the 11th PKO Night Wrocław Half Marathon.
2. In order to ensure safety **it is prohibited** for Competitors:
 - a. to participate in the Race on roller blades, roller skates, skateboards, bicycles, scooters, or to use Nordic walking or trekking poles or sticks;
 - b. to participate in the Race in wheelchairs with an indirect drive (e.g. hand-bike) and

- rim-push type, or in wheelchairs with an electric drive;
- c. to run with pet animals;
- d. to participate in the Race under the influence of alcohol, drugs or other intoxicants.
3. In order to run the Race and be included in the Race final results announcement each Competitor must register and pay the entry fee.
 4. In order to run the Race and be included in the Race final results announcement all Competitors must wear their race number during the entire Race, move only along the route specified by the Organiser, and go through all time control checkpoints.
 5. Throughout the Race, all Competitors must have their race numbers (bibs) attached to the front of their shirt, at the chest line. Obscuring the race number (entirely or partially) during any part of the Race or taking short-cuts is prohibited under the penalty of disqualification.
 6. The timing chip is integrated with the Competitor's race number. Tampering with the timing chip or placing the race number anywhere other than horizontally on the front on the chest line may result in improper functioning of the timing chip and, consequently, the lack of the Competitor's result.
 7. The Organiser does not allow for Competitors to start with a someone else's race number and chip. Starting with a race number and/or chip assigned to someone else results in the disqualification.
 8. Race numbers are assigned at the Race Office, Competitors may not select their number.
 9. The Organized **shall not issue duplicates** of race numbers.
 10. The Organiser allows participation of Competitors in wheelchairs with a direct drive. Competitors shall start with one assistant. Having filled in a registration form such
 11. Throughout the Race, Competitors must follow instructions given by safety personnel, security services, uniformed services, and other individuals designated by the Organiser (with the Organiser's accreditation).
 12. Competitors in the Race must adhere to the rules of the PZLA WA, AIMS, and these Rules and Regulations.
 13. Competitors must adhere to any sanitary recommendations binding on the Race date as specified by relevant sanitary authorities and by the Organiser.

X. ENTRIES

1. The Organiser sets the following limit for entries: 12,000 Competitors. Entry confirmation is guaranteed only when the race fee has been paid.
2. The Race Competitors list closes after 12,000 Competitors are registered. The Organiser reserves the right to change the afore said limit. The Organiser does not keep a standby list. Changing the Competitors limit does not require amendment to these Rules and Regulations. The Organiser shall inform about any changes to the Competitor limit on the Race website: www.mcs.wroc.pl/polmaraton. The Race kit fee for additional Competitors shall be specified by the Organiser on the date of announcing the additional number of Competitors allowed to run in the Race.

3. Signing-up for the 11th PKO Night Wrocław Half Marathon shall be accepted only through the electronic registration form that will be made available at the Race website: www.wcs.wroc.pl/polmaraton.
4. Signing-up for the Event is deemed complete if the following two conditions are met in the following order:
 - a) the registration form is correctly filled in,
 - b) the race kit fee is made in the Internet entry panel (the payment must be credited to the bank account).
5. By signing up to participate in the 11th PKO Night Wrocław Half Marathon Competitors also accept these Rules and Regulations and agree to adhere to them, as well as agree for the free use of their image in all exploitation fields (the press, radio, TV, the Internet, printed materials). Competitors also agree for being sent information and questionnaire forms concerning any events organized by the Youth Sports Centre in Wrocław.
6. Once the payment is credited to the bank account, the Competitor's personal data shall appear on the Race Competitors List.

XI. CONSENTS

1. By signing up to participate in the Race, each Competitor also consents:
 - a) that their image is used for promotion, marketing and information purposes related to the Event, including their publication in media, promotion materials and on the Organiser's website;
 - b) that their name and surname are made available at the competitors' wall at the Race Office, with the exception of competitors who in their registration form declared as "anonymous competitors".

XII. FEES

1. Each Participant of the 11th PKO Night Wrocław Half Marathon shall bear the entry fee.
2. The entry fee may be paid online (redirected from the registration profile) via the *Imoje* service. The entry fee may not be paid either in cash or by payment card.
3. The entry fee covers the race kit mentioned in Chapter XI (6) hereof, services provided to a Competitor before, during, and after the Race, the Race organization costs, personal accident insurance premium.
4. The entry fee amount depends on the date of its payment, not on the Race entry date.
5. Competitors shall make sure whether their payment order was effected. The Organiser disclaims any liability due to the lack of payment for reasons depending on the payer's bank / the *Imoje* service.
6. Each Competitor shall receive a race kit that includes:
 - a. a race number with a chip and safety pins,

- b. the Race Rules and Regulations and the Race route map (online)
 - c. sponsors' gadgets, information/promotion materials
 - d. a deposit bag
 - e. personal accident insurance
 - f. water, isotonic drinks, refreshments along the Race route
 - g. at the finish line water, drinks, a regeneration meal
7. The Race kit does not include the official T-shirt.
 8. The official T-shirt and other gadgets of the 11th PKO Night Wrocław Half Marathon shall be sold by the Race Technical Partner at their website: <https://www.adrunal.pl>, irrespective of the Race Competitor's registration.
 9. The purchased T-shirt and other gadgets may be collected at the Race Office, at the Race Technical Partner's stand.
 10. The Organiser does not assist in the purchase of the official T-shirts or other Race gadgets.
 11. Race kit fee rates :
 - a. up to 4,000 Competitors – PLN 149
 - b. up to 8,000 Competitors – PLN 189
 - c. up to 12,000 Competitors – PLN 220
 12. Competitors may purchase a voucher:
 - a. up to 4,000 Competitors – PLN 159
up to 8,000 Competitors – PLN 199
up to 12,000 Competitors – PLN 230
 - b. The Organiser disclaims any liability for the manner of the use of vouchers after they have been purchased.
 - c. One person may purchase maximum 2 vouchers.
 - d. Vouchers must not be sold to any third parties.
 - e. Vouchers may not be returned or assigned to subsequent years.
 13. Competitors may pay PLN 25 for extra engraver's services at signing up for the Race or after the Race.
 14. Competitors may resign from the participation in the 11th PKO Night Wrocław Half Marathon by 31 March 2025. In order to resign a Competitor must email information to: biuro.zawodow@mcs.wroc.pl. The entry fee shall be refunded 14 days upon the receipt of the email.
 15. The Race Competitors may transfer their entry fees from the level of their registration profile. Entry fees may be transferred by 6 June 2025. Financial settlement between the competitors shall be effected outside the system. In order to transfer the entry fee paid be them a Competitor should log into their Datasport profile, go to the competitor's panel and click the "generuj cesję" ("generate the transfer") button. A link for transferring a Race kit fee to a transferee shall be emailed to the address as specified in the Competitor's profile.
 16. The Organiser disclaims any liability due to any mistakes made by Competitors while

transferring their entry fees to another Competitor. The Organiser does not assist in the settlement of Competitors.

17. Competitors who wish to get their entry fee invoiced shall tick a relevant box in the entry form and enter required data correctly. In case of any problems please contact factory.zawody@mcs.wroc.pl.
18. Competitors who wish to get a proforma invoice shall email the relevant data, the number of competitors and a list of their names (the competitors should be already signed up for the Race) to factory.zawody@mcs.wroc.pl.

XIII. DISCOUNTS

1. The following Competitors are eligible to purchase a race kit for PLN 1, provided that they register before the Competitors' limit runs out:
 - a. The Golden Two of the Wrocław Marathon (Competitors who finished all Ślęzan Marathons and Wrocław Marathons)
 - b. The Ślęzan Marathons, Wrocław Marathons, and Night Wrocław Half Marathons winners
 - c. The 10th PKO Night Wrocław Half Marathons age category winners
 - d. Competitors born on 14.06.1965 or before (60+ age old)
 - e. Competitors invited by the Race Organiser
2. Competitors with disabilities have the right to a 50% discount on a race kit. Competitors who move in wheelchairs should start with an assistant. They are eligible for the discount provided that they register before the limit of Competitors runs out and they email or present at the collection of their race kit their disability confirming documents and they provide personal data of their assistant in their entry form.
3. The following Competitors are eligible to participate in the Race free of charge:
 - a. persons invited by the Organiser
 - b. winners in contests.

XIV. CLASSIFICATION

1. Classifications in the 11th PKO Night Wrocław Half Marathon:
 - a. women and men
 - b. age classification for male and female citizens of the Republic of Poland: 18-29, 30-39, 40-49, 50-59, 60-69, 70-79, 80+
 - c. team classification (three best team members, irrespective of their sex, provided that they enter the identical team name – the winner is the team whose members summary time ranks best).
2. The Organiser reserves the right to create additional classifications.
3. The basis for classification is electronic time measurement.
4. Lack of time measurement at any of the time control checkpoints may result in

disqualification.

5. The Race classification is based on actual times (net time – counted from crossing the start line). An exception is the first 50 Competitors crossing the finish line – they will be classified based on official times (gross time – counted from the starter's shot).

XV. RESULTS

1. The Race unofficial results shall be published at www.mcs.wroc.pl/polmaraton promptly after the Race.
2. Complaints, comments and conclusions concerning the participation and protests concerning results of the 11th PKO Night Wrocław Half Marathon may be filed in writing to the Organiser or by email to: biuro.zawodow@mcs.wroc.pl within 3 days after the end of the Race. Protests shall be examined within 96 hours.
3. The Race official results shall be published at the website by 1st of July 2025.

XVI. AWARDS

1. All Competitors who finish the 11th PKO Night Wrocław Half Marathon will receive keepsake medals at the Finish line.
2. Winners of the 1st, 2nd and 3rd places in the general women and general men classifications will receive cups and the following cash prizes:
 - a) PLN 8,000 – 1st place
 - b) PLN 6,000 – 2nd place
 - c) PLN 5,000 – 3rd place
3. Winners of the 1st, 2nd and 3rd places in general classification of citizens of the Republic of Poland will receive cups and the following cash prizes:
 - a) PLN 4,000 – 1st place
 - b) PLN 3,500 – 2nd place
 - c) PLN 3,000 – 3rd place
4. Winners of the 1st, 2nd and 3rd places in team classification will receive cups.
5. Winners in age categories will be granted a discount on the entry fee for the 12th Night Wrocław Half Marathon as mentioned in Chapter XII (1) hereof.
6. The Organiser reserves the right to award additional awards, including cash prizes, in categories and classifications selected at his sole discretion.
7. Finishing the Race and – in the event of running a doping control – its negative result are the condition for receiving a prize.
8. Advance personal income tax deductions shall be made from the cash prizes, as provided for in applicable tax regulations.
9. Cash prizes shall be transferred to bank accounts provided by Competitors, by 31 of July 2025. Prizes are not paid in cash.
10. Cash prizes shall be transferred to relevant bank accounts provided that the Organiser receives all necessary forms filled in by winners as demanded by tax authorities, not later than 30 days after finishing the Race.

XVII. DOPING CONTROLS

1. The Organiser reserves the right to run a doping control, and accepting these Rules and Regulations is deemed to be a consent for such a control.
2. The tests shall be run by the Sports Anti-Doping Commission. Each Competitor selected by the Commission must undergo doping tests, otherwise they shall be disqualified.
3. If prohibited substances are detected in sample A, a Competitor may request that sample B be tested at their expense. If the sample B proves negative not confirming that the Competitor used prohibited substances, the Competitor remains in the list. If the sample A proves positive, the Organiser of the 11th PKO Night Wrocław Half Marathon disqualifies the Competitor. The disqualification decision is final and no PZLA appeal regulations apply to it.
4. The list of prohibited substances and methods is specified in Schedule 1 to the International Anti-Doping Convention dated 19.05.2005, as amended.

XVIII. SERVICES PROVIDED BY THE ORGANISER

1. The deposit area:
 - a. will be located in the Olympic Stadium (al. I. J. Paderewskiego 35 51-612 Wrocław). Subject to items (b) and (e) herein below, it will be open from 14th of June 2025, 6:00 p.m. till 15th of June 2025, till 2:30 a.m.
 - b. Competitors may deposit their belongings on 14th of June 2025, from 6:00 p.m. till 10:00 p.m.
 - c. Deposited items shall be marked with numbers and put in bags.
 - d. It is prohibited to deposit valuable or fragile items or documents. The Organiser disclaims any liability for such items.
 - e. Deposited items may be reclaimed after presenting the ticket till 15th of June 2025, 02:30 a.m. After the deposit area is closed, Competitors should contact the Organiser via email: biuro.zawodow@mcs.wroc.pl.
 - f. In the event when a Competitor loses their ticket, the Organiser disclaims any liability for such deposited items being reclaimed by any third party.
 - g. The Organiser shall not be held liable for any items left in deposit or left in the deposit area outside the specified work hours.
2. Changing rooms, showers and toilets will be available at the Olympic Stadium.
3. The Organiser shall ensure medical care at the Race start and finish lines, as well as along the Race route.
4. Organiser shall provide water and a regeneration meal at the Race finish line.
5. The Organiser shall provide the personal accident insurance for Competitors (for the time of the Race).
6. The Organiser shall not provide any accommodation.

XIX. FINANCING

1. Any costs of the 11th PKO Night Wrocław Half Marathon shall be borne by:
 - a) The Municipality of Wrocław,

b) Partners and institutions supporting the 11th PKO Night Wrocław Half Marathon.

XX. FINAL PROVISIONS

1. By filling in the entry form Competitors confirm that they participate in the Race at their own responsibility. They declare that they are fit to participate in the Race and they are not aware of any reasons of health nature that may exclude them from taking part in the Race and they acknowledge that participating in the race involves physical effort and carries the risk of accidents, bodily injuries, and physical injuries (including death), as well as damage and financial loss.
2. The decisions of doctors regarding the continuation of the Race are final and irreversible.
3. The Organiser recommends undergoing medical examination before the Race, depending on the Competitor's age and physical condition.
4. It is prohibited to take to the Race route any materials that may prove hazardous for the Competitors, including but not limited to intoxicants, drugs, alcohol, or other illegal substances.
5. Any behaviour inciting violence, or wearing symbols inciting violence or supporting war by Competitors or any individuals staying within the Event zone are strictly prohibited. Any persons that refuse to observe the ban shall be removed from the Event zone.
6. It is prohibited to be on the Race route without a valid race number. Individuals without a valid race number will be removed from the route by the Event staff.
7. Only vehicles with a valid pass issued by the Organiser and displayed in a visible way are allowed on the route during the Race.
8. During the Race, Competitors must follow the instructions given by safety personnel, security services, and other individuals designated by the Organiser.
9. By filling in the entry form signing up to participate in the Race Competitors accept these Rules and Regulations and agree to adhere to them, and agree for the free use of their image in photographs, advertisement graphics or video recordings in all exploitation fields.
10. The Organiser reserves the right to send information on the 11th PKO Night Wrocław Half Marathon to the email address indicated in the entry form.
11. It is the sole right of the Organiser to place any advertisements on the Race infrastructure elements, especially any elements advertising the official Race Partners. It is prohibited to display any advertising materials in the Start and Finish lines, as well as within the area used to organize the Race (the Race town) without the Organiser's written consent.
12. The Organiser reserves the right to stop the Race should any circumstances that require this kind of Organiser's intervention appear.
13. The Organiser reserves the right to cancel the Race or change its date in case of:
 - a. any events of force majeure appear that may affect the Race;
 - b. epidemiological situation in the territory of the Republic of Poland concerning e.g. SARS-CoV-2 or other viruses that may prove hazardous to the Competitors or Event staff;
 - c. introduction of general restrictions that would make it impossible to carry out the Race or substantially impede its organization;
 - d. occurrence of events that were unforeseeable at the date of announcing the Race and make it impossible to carry it out.
14. In the meaning of these Rules and Regulations force majeure shall mean any



unforeseeable events and situations of extraordinary nature that are beyond the Organiser's control that make it impossible to fulfil any obligations provided herein, that are not result of the Organiser's errors or negligence and that are insurmountable, in spite of applying due care, and in particular: natural disasters, such as flood, hurricane, high winds or long-lasting downpour of rain, or unforeseeable extraordinary and external events (such as war, martial law restrictions, uprising, revolution, riots, terrorists attacks), threat of epidemics, epidemics state, epidemics or epidemic state, as well as new law regulations or administrative decisions that make it impossible for the Organiser to fulfil his obligations.

15. The Organiser reserves the right to change the Race route, date, hour, divide the Race into waves or to resign therefrom, the limit of Competitors, introduce additional restrictions and sanitary requirements, to change the number of water/refreshment stations and their supplies, to take any other actions that may deem necessary to make the Race possible in the light of applicable law regulations and to ensure security to the Competitors and staff.
16. The Organiser reserves the right to make amendments or changes to these Rules and Regulations. In such an event the Organiser shall inform the Competitors on the website: www.mcs.wroc.pl/polmaraton
17. The irreversible and final interpretation of these Rules is reserved for the Organiser of the 11th PKO Night Wrocław Half Marathon. Any matters not included herein shall be governed by the Organiser.

XXI. PERSONAL DATA PROTECTION

1. According to Art. 13(1) and (2) of the Regulation (EU) 2016/679 of The European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter referred to as the GDPR):
2. For Competitors of the 11th PKO Night Wrocław Half Marathon:
 - a. the Controller of the Personal Data (CPD) included in the entry form is the Wrocław Youth Sports Centre with its official seat at al. I. J. Paderewskiego 35, 51-612 Wrocław.
 - b. The CPD appointed the Personal Data Inspector that is the contact person for correspondence either by mail to the address specified in item (1) hereinabove or by email to the following addresses: iod@mcs.wroc.pl or sekretariat@mcs.wroc.pl.
 - c. The personal data shall be processed based on the agreement related to the participation in the 11th PKO Night Wrocław Half Marathon, legal basis: Art. 6(1)(b) of the GDPR (your personal data shall be processed in order to conclude the agreement and fulfil its conditions, make any financial settlements within the applicable period of time). If you declare that you are in good health, your personal data shall be processed on the basis on your consent – legal basis Art. 9(1)(a) of the GDPR. If you consent to getting to you email address information and questionnaires concerning the 11th PKO Night Wrocław Half Marathon, the legal basis Art. 6(1)(a) of the GDPR.
 - d. Your personal data may be transferred by the CPD to the following recipients:

- processing entities hired by the CPD to process such data;
 - other recipients, such as insurance companies, e-payment services, banks, Internet service providers.
 - e. Your personal data shall be processed for a period of 5 years, i.e. in the period when the CPD is obliged to fulfil his rights and obligations resulting from law regulations binding for Organiser of the Event and in case when you consent to your health data processing, for a period not longer than 5 years or by the date of withdrawing your consent for your data processing.
 - f.
